

Terms for providing “data toppings (Japan SIM)”

KDDI Corporation and Okinawa Cellular Telephone Company (hereinafter collectively “the company”) will provide the following data toppings on povo2.0 services as prescribed in the povo2.0 Communication Service Contract Terms and Conditions. The official text of this Agreement is in Japanese, and any translations into other languages are for reference purposes only. In the event of any discrepancy between the Japanese version and any translated version of this Agreement, the Japanese version shall take precedence.

1. Overview

Customers subscribed to povo2.0 can use data toppings according to their usage (such as using unlimited data for 7 days and having a 10 GB data top-up.)

2. Terms of Service Provision

(1) Basic information about data toppings

Data topping category	Usage fees	Amount of data	Effective period
Unlimited data (7 days)	4,090 yen/session without tax (4,500 yen/session, including tax)	Unlimited data*1	7 days
Data Top-up 10 GB (30 days)	3,455 yen/session without tax (3,800 yen/session, including tax)	10 GB	30 days
Data Top-up 3 GB (7 days)	2,000 yen/session without tax (2,200 yen/session, including tax)	3 GB	7 days
Data Top-up 1 GB (30 days)	2,000 yen/session without tax (2,200 yen/session, including tax)	1 GB	30 days

*1 Data speed may be limited during network congestion and when using videos, cloud games, etc. For more details, see (2)-2).

(2) Important matters

1) Application and abolition of the toppings

[Universal]

- Toppings purchased through other companies' apps etc. will start to apply as soon as the purchase procedure is completed.
- As for the entry code, its corresponding topping will start to apply when the SIM etc. of the povo2.0 contract involved in the entry code's registration is activated.
- If purchased through other companies' apps etc., usage fees will be paid at every purchase (not monthly) using a payment method we specify that is registered on your povo2.0;
- The communication to purchase toppings via other companies' apps etc., will consume data from your currently applied topping.
- Data toppings purchased at different times will have their respective expiry dates. Even if you purchase a new data topping before a previously purchased data topping expires, the expiry date of the previously purchased topping will not be extended.
- If your povo2.0 contract is canceled, the topping will stop and the remaining data allowance and the unlimited hours will be canceled.
- Cancellation is not accepted once the purchase procedure is completed.

[Unlimited data toppings]

- Until the unlimited-data period expires, you will be able to use communication regardless of the amount of data transmitted, without the Base Plan's (Japan SIM) speed limit of 128 kbps applying, or spending any previously purchased data.
- Counting 24 hours from the time the topping starts to apply as one day, the effective period will last until the time the number of days each data topping specifies has passed.
- Please note that for the time being, you will be able to use communication until the end of the last day of your effective period, without the Base Plan's (Japan SIM) speed limit of 128 kbps applying, or spending any previously purchased data.
- Additional unlimited data toppings are unavailable for purchase during the unlimited-data period.

[Data toppings except for unlimited data toppings]

- During the unlimited-data period, or until you use up all the data you purchased during the unlimited-data period, you will be able to use communication without the Base Plan's (Japan SIM) speed limit of 128 kbps applying
- Counting 24 hours from the time the topping starts to apply as one day, the effective period will last until the time the number of days each data topping specifies has passed.
- Please note that for the time being, you will be able to use communication until the

end of the last day of your effective period without the Base Plan's (Japan SIM) speed limit of 128 kbps applying until you use up the entire data allowance you purchased.

- The data pertaining to the data toppings that started to apply when the entry code was entered will be consumed as a data bonus in the order prescribed in the terms of service for the Base Plan (Japan SIM).

2) Communication speed limit

[Universal]

- Communication speed will be limited during periods of network congestion if you use large amounts of data in a short period.

[Unlimited data toppings]

- Data speed may be limited for services such as videos and cloud games that will involve large amounts of data communication or connection for a long time, to the extent that it does not affect general usage on smartphones (such as watching videos in full HD quality.) We will specify which services and content this will affect, considering matters such as impact on our networks. This will not shut down communication.

■ About these terms of service provision

- We may update the terms in this document. In such cases, fees and other terms of service provision will be as prescribed in the terms after the update. We will notify you of the new terms and when they will take effect on specified websites and by other similar means, and the new terms shall become valid from the said activation time.
- Any case falling under the Regulation for Enforcement of the Article 22-(2)-3-2-1 of the Telecommunications Business Act (Order of the Ministry of Posts and Telecommunications, 1985, Act No. 25) in which we update the terms of service provision by filing an application, we will release the details on our webpage in advance instead of notifying and providing an explanation to individual customers.
- Terms of service provision (including the povo2.0 Communication Service Contract Terms and Conditions and our other various terms of service and rules) etc. will apply to matters not prescribed in these Terms of Service Provision. Details such as terms of service are available on our webpage.
- Other terms of service provision for povo2.0 will be as prescribed on channels such as our webpage.
